Pursuant to the Civil Aviation Regulation of the Islamic Republic of Iran for the time being in force and subject to the conditions specified below, the Civil Aviation Organization of the Islamic Republic of Iran (CAOIRI) hereby certifies:

as a continuing airworthiness management organization in compliance with Section A, Subpart G of CAOIRI Part-M, approved to manage the continuing airworthiness of the aircraft listed in the attached schedule of approval and, when stipulated, to issue recommendations and airworthiness review certificates after an airworthiness review as specified in point M.A.710 CAOIRI Part-M, and, when stipulated, to issue permits to fly as specified in point M.A.711(c) of CAOIRI Part-M of the same regulation.

Conditions:

1. This approval is limited to that specified in the scope of approval section of the approved continuing airworthiness management exposition as referred to in Section A, Subpart G of CAOIRI Part-M.
2. This approval requires compliance with the procedures specified in CAOIRI Part-M approved continuing airworthiness management exposition.
3. This approval is valid whilst the approved continuing airworthiness management organization remains in compliance with CAOIRI Part-M.
4. Where the continuing airworthiness management organization contracts under its Quality System the service of an/several organization(s), this approval remains valid subject to such organization(s) fulfilling applicable contractual obligations.
5. This approval does not constitute an authorization to operate the types of aircraft referred in paragraph 1. The authorization to operate the aircraft is the Air Operator Certificate (AOC).
6. Termination, suspension or revocation of the AOC automatically invalidates the present approval in relation to the aircraft registrations specified in the AOC, unless otherwise explicitly stated by CAOIRI.
7. Subject to compliance with the previous conditions, this approval shall remain valid until any specified date of expiry, unless the approval has previously been surrendered, suspended or revoked.


